Key features of the US model include: decentralized management; various pedagogical programs (Montessori, Reggio Emilia, HighScope, and others); an approach focused on individual development trajectories; emphasis on early literacy and mathematical readiness; social protection programs (such as Head Start). The assessment system is mainly carried out through development indicators and observation charts. Its strength is methodological flexibility, while its limitation is the existence of quality differences across regions.

Preschool education in China is strictly regulated by the state. Curricula and methodological requirements are set at the national level. In recent years, there has been a

policy of significantly expanding preschool education coverage. Key features of the Chinese experience: unified national standards; education oriented towards discipline and group activities; combination of play and structured activities; priority given to moral and social education; mandatory professional development system for educators. In the Chinese preschool education system, assessment is mainly conducted through pedagogical observation and developmental indicators. The advantage of the model is its systematic approach and control, while a drawback is the high academic workload in some regions.

The Singapore preschool education system is distinguished by high-quality control and clear methodological guidelines. The national framework “Nurturing Early Learners” serves as a methodological basis for all institutions. The main directions of the Singapore model are: strict quality monitoring by the state; integrated development (speech, thinking, socio-emotional); bilingual education model; compulsory certification of teachers; systematic cooperation with parents.

play-based learning is given priority; monitoring across 7 areas of development; individual development charts; principles of inclusive education; quality control through external inspection. The main goal of preschool education in Japan is to adapt the child to community life and to develop independent action skills. The education model is closely linked to cultural values. Key aspects of the Japanese experience:
